



# Head of the School Scholarship

Open to one new male student and one new female student looking to enter the School in Year 7 in 2021, the Head of the School Scholarship provides educational opportunity to students with proven academic performance and high potential, but who do not have the financial means to experience a St Michael's education.

The Head of the School Scholarship is tenable until the end of Year 12 and offers remission of tuition fees.

Students are required to sit the Academic Scholarship examination.

*\* The award of the Head of the School Scholarship is a means tested scholarship and is available to students who for financial reasons cannot attend St Michael's Grammar School. Offers will take into account the financial means of the applicant's parents.*

# Head of the School Scholarship Overview

## Criteria for awarding scholarship

The Head of the School Scholarship is awarded to one male student and one female student, not yet at the School, entering in Year 7 in 2021.

The Scholars will be individuals who:

- would not ordinarily be able to attend St Michael's based on their family's current financial situation
- demonstrate high academic potential and proven academic performance
- share the School's values of Dignity, Respect, Care and Compassion
- will embrace the School's culture of contributing citizenship and reciprocity
- will gain from and engage with the diverse range of programs offered by the School
- will contribute positively to the School and broader community.

### Specific application criteria:

1. Applicants will complete the applicant statement.
2. Applicants will score results between Stanine 7-9 in all the School's Academic Scholarship examination categories.
3. Applicants will have academic awards/certificates.
4. Applicants will show proven and consistent results in their learning (via documented School Reports, NAPLAN and/or standardised test results).
5. Applicants will provide a statement of financial position as part of the application process.
6. Prior to a scholarship offer being made, short-listed applicants will provide further financial supporting documentation to satisfy the means-testing criteria set by the School.

The St Michael's Grammar School Scholarship Program operates subject to the School's Scholarship Policy. Scholarships are awarded at the discretion of the Head of the School, and the Scholarship holder is subject to all terms and condition of enrolment.

## Costs covered by the scholarship

Tuition remission offered based on results of application criteria and assessment of the family's financial position in the St Michael's Grammar School means-testing criteria.

Remission of costs of enrolment including the Registration fee, Confirmation of Enrolment Fee, and Advance of School Fees will also be based on results of application criteria and assessment of the family's financial position in the St Michael's Grammar School means-testing criteria.

## Costs not covered by the scholarship

All additional and associated costs which pertain to the student's education.

## Role of the School

The School will provide places to scholarship recipients at agreed discount rate. The scholarship offer is not negotiable.

The School will advertise the scholarship opportunity to prospective students, short-list applications and award scholarships.

Subject to funding availability, this scholarship is awarded to a student or students currently attending, or not yet at the School.
