\*The levy is imposed to assist the School in the maintenance and upkeep of the facilities, computer network and provision of the School's compulsory Outdoor Education Program.

## Discounts and concessions

### Sibling discount

- 10% for the 2nd child or another child in the same year level
- 25% for the 3rd child and any subsequent siblings.

### Annual fee in advance discount

3% discount applies to tuition fees only if prepaid by 20 November 2018.

### Fee locking due date

Where an account holder elects to pay multiple years in advance, the fee shall remain capped for the applicable year level for the duration of the payment, therefore future increases to fees will not apply. For example, if a parent elects to also pay for 2020 and 2021 then the fee shall remain set at the 2019 rate until the conclusion of 2021. Full payment is required by 28 January 2019.

## New Student

### Confirmation of Enrolment Fee

\$1,800 (non-refundable) to accompany acceptance of enrolment offer and secure the new student's placement.

### Advancement of School Fees

\$1,200 payable upon acceptance of enrolment offer. This amount will be credited against the student's fees after Term 2 of the enrolment year.

## Payment of fees and charges

The School offers families two methods of fee payment for annual tuition fees and levies, either 12 equal monthly instalments or annual prepayment of fees in advance.

Payments for 2019 fees and levies commence in October 2018.

The School accepts payment by direct debit only; either through a nominated financial institution or by credit card. Payments made by credit card will incur an 0.7% surcharge.

Invoices are issued at the end of each month, for tuition, levies and any additional co-curricular and extra-curricular charges incurred.

Full payment is due by direct debit on the 20th of the following month.

## Voluntary termination of enrolment
